Blue Mountain Trust (BMLT) is searching for a development director to strategize, plan, organize, and lead BMLT's fundraising efforts across a range of initiatives.

We are looking for an experienced development director who can lead and grow BMLT's fundraising efforts to support its conservation, stewardship, and community engagement programs with integrity, collaboration, creativity, and enthusiasm. The development director is responsible for developing and executing a strategic long-term development plan to advance BMLT's institutional goals, including annual giving, major gifts, foundation grants, corporate support, special events, and building relationships in the community. The development director works closely with the executive director, marketing and communications director, other staff, and board of directors to lead donor engagement, monthly and planned giving programs, grant strategy, annual campaign, and 25th-anniversary fundraising events.

# **Job Role & Responsibilities**

### Fundraising

- Create, direct, and lead annual development strategy including annual giving campaigns, donor cultivation, monthly and planned giving, major gifts, and other special events such as BMLT's 25th anniversary campaign. Track and analyze progress towards achieving revenue and communications goals.
- Collaborate with the executive director, marketing and communications director, other staff and BMLT's board to fulfill fundraising plans and meet projected financial needs.
- Maintain a portfolio of key individual and institutional supporters. Develop and build relationships with donors, community members, corporate sponsors, partners, grantors and foundations through a meaningful stewardship strategy to communicate BMLT's mission, goals, and programs and garner support. Identify and steward new and existing donor relationships with authenticity and transparency.
- Build and maintain systems for cyclical giving campaigns, corporate support, donor stewardship, grant applications, grant reports, and more.
- Lead and work collaboratively with BMLT's development and donor database consultants to manage confidential donor information, track progress, and ensure secure and accurate data management.
- Work collaboratively with the marketing and communications director to create fundraising campaign messaging, fundraising collateral, and donor communication touchpoints with the goal of reaching new supporters, and growing community understanding of BMLT's impact.

# **Grants Management**

- Lead foundation, corporate, and government grant application efforts, workflows, and report follow-up. Collaborate with BMLT staff to determine funding opportunities and provide assistance on grants to support the organization's goals and projects.
- Identify and pursue new funding opportunities and programs. Build relationships with funders, manage awarded grants, and maintain detailed records of awarded funds.

# Partnership Building & Management

- Meet and establish clear and consistent communication with community members, partners and stakeholders, including making public appearances or accepting speaking engagements, to share information about BMLT with the community.
- Participate in and contribute to internal and external organizational diversity, equity, inclusion, and justice (DEIJ) work. Ensure DEIJ principles are integrated into BMLT's fundraising and outreach efforts.



#### **General & Financial**

- Assist the executive director with developing the annual fundraising and organizational budget. In collaboration with the executive director and finance committee, manage development revenue and expense budgets and forecasts.
- Manage awarded grants, grant reporting, and track project deliverables, contracts, and expenditures.
- Work with the executive director and other staff to ensure compliance with program policies and Land Trust Alliance (LTA) accreditation best practices and requirements.
- Assist other work and program tasks as needed to support BMLT funding goals, priorities, and needs.

Ability to regularly travel throughout BMLT's 11-county service area, often to remote locations, for site visits to properties and project meetings. BMLT has a work vehicle for use and offers mileage reimbursement at State Government rates for personal vehicle use.

- Occasional site visits are performed outdoors in conditions that include steep and rough terrain, dense vegetation, inclement weather, and on muddy, uneven, or rocky surfaces.
